## BOOKING TERMS AND CONDITIONS

This page sets out the terms on which Porsche Club GB Motorsport Ltd arranges track days for online bookings. Please take the time to read these terms and conditions carefully before booking on this site - remember that our team can be contacted via email at [trackdays@porscheclubgb.com](mailto:trackdays@porscheclubgb.com) and will be happy to deal with any enquiries you may have.

By booking a track day, you agree to abide by these terms and conditions. Your booking and your participation in the track day are also subject to the Car Track Day Regulations. If you do not agree to these terms and regulations, please do not proceed with your order.

### **About Porsche Club GB Motorsport Ltd**

Porsche Club GB Motorsport Ltd, (PCGBMS) is a company registered in England and Wales under company number 4580257 with our registered office and trading address at, Cornbury house, Cotswold Business Village, Moreton-in-Marsh, Gloucestershire, GL56 0JQ. VAT number is 807311458.

### **How the contract is formed between you and Porsche Club GB Motorsport Ltd**

All orders are subject to acceptance by PCGBMS, and PCGBMS will confirm such acceptance to you by sending you an e-mail that confirms the track day has been purchased. The contract between us will be formed when we send you the confirmation email. By booking a track day through the site you warrant that you are legally capable of entering into binding contracts.

If you do not receive the confirmation emails or you are unsure about any matter regarding your booking, please email the track day team at [trackdays@porscheclubgb.com](mailto:trackdays@porscheclubgb.com). Please check your spam/junk folder if you do not receive the email. Non receipt of the email could also be down to incorrect spelling, so please don't assume it didn't work email us.

### **Booking on behalf of Someone Else**

You will be responsible for bearing any cost incurred as a result of cancellation or the relevant person's non-attendance at the track day. We are unable to provide refunds other than to those customers who have booked directly with us. All monies refunded will be refunded back to the card used to make the payment.

If you have any doubt that anyone for whom you are booking a track day is or may not be able to comply with any of the terms of this agreement, please do not proceed with that booking and advise such person(s) to book direct or contact our track day team.

### **Price and Payment**

The price of track day bookings will be as quoted on the site from time to time, except in cases of obvious error. These prices include VAT. Prices may change at any time, but changes will not affect orders in respect of which PCGBMS has already sent a confirmation email.

Payment must be by credit or debit card. We accept payment using Visa, MasterCard, Switch, Solo and Maestro. The only currency we currently accept is Pounds Sterling (GBP). Please note we do not accept American Express Cards.

### Availability

All track days are subject to availability. Please check the details of your track day booking set out in the confirmation email as mistakes cannot always be rectified.

### Cancellations

#### (a) Cancellation by PCGBMS

PCGBMS may have to cancel a track day due to events beyond its control, for example adverse weather conditions, COVID. This will usually be in the interests of safety. Where a track day is cancelled in its entirety for such reasons, PCGBMS will endeavour to notify participants of the cancellation although PCGBMS cannot guarantee that participants will be informed of such cancellation before the date of the event. Where a track day is cancelled in its entirety for such reasons PCGBMS are unable to reimburse third party costs incurred due to the cancellation but will endeavour to offer either (a) a full credit towards a place on an alternative, later track day (subject to availability) up to the face value of the existing booking or, (b) if PCGBMS cannot provide an alternative date, a full refund.

If PCGBMS cancel a track day for reasons other than events beyond its control, a full credit, transfer or refund will be offered.

In order to claim any refund, please apply in writing to PCGBMS's address set out at the start of these terms and conditions, or email [trackdays@porscheclubgb.com](mailto:trackdays@porscheclubgb.com) stating clearly the track day to which the application relates. For accounting purposes any applications for refunds must be received within 28 days from the date of the cancelled track day.

#### (b) Cancellation by you

If you are unable to attend the track day, please email the PCGBMS team as soon as possible to [trackdays@porscheclubgb.com](mailto:trackdays@porscheclubgb.com). In these circumstances, provided PCGBMS are notified no later than **14 days prior to the original booked track day date**, PCGBMS will endeavour to reschedule your booking or provide an PCGBMS credit towards a later track day (subject to availability) up to the face value of the existing booking\*. Any credit held by PCGBMS must be used within a three-month period from the date of cancellation. The PCGBMS product you are booking does not need to take place within three months; you must simply have used your credit. For example, if you cancel your track day on the 1st January, you must have booked an alternative date by the 1st April. Any credits not used within the 3-month period automatically expire. It is your responsibility to redeem the credit in time. Should PCGBMS be notified **within 14 days prior to the original booked track day date** and the trackday is fully booked we will attempt to contact any available reserves and if a successful replacement is found then we will issue you an PCGBMS credit less the admin fee\*. You may also let us know of a name change and we will action this with a 10% fee. If we are unable to find a replacement prior to the event, then we will not be able to issue the PCGBMS credit.

Any amendments to track day bookings must be requested by email [trackdays@porscheclubgb.com](mailto:trackdays@porscheclubgb.com), stating clearly the track day to which the amendment relates.

\*Any cancellations or amendments of the track day date, requested by you, will incur an administration fee of 20% or £40 whichever is the greater. All offers of credit are entirely at the discretion of PCGBMS.

It is your responsibility to ensure that your vehicle meets the relevant noise test requirements. If your vehicle fails any noise test and you are excluded from any further participation PCGBMS will have no liability to you and you will not receive any refund or date transfer in relation to the event. Similarly, if your vehicle suffers mechanical issues which prevent or limit participation, no refund or transfer will be given.

### **Variations**

PCGBMS may vary the format and / or timetable of an event if required. Participants will be notified of any such change as soon as possible.

PCGBMS may revise these terms at any time by amending this page or the relevant document.

### **Acknowledgement of Risk**

## CAR TRACKDAY REGULATIONS

### **Acknowledgement of Risk**

Motorsport is dangerous and can involve injury or death. Despite Porsche Club GB Motorsport Ltd (PCGBMS) taking all reasonable precautions, accidents can happen. By attending a track day, you acknowledge this and confirm that you are aware of the nature of the activity and attend at the venue at your own risk.

PCGBMS may refuse access to, and eject from, venues any persons who are acting against the interests of safety and/or whose behaviour is likely to cause damage, nuisance, or injury. PCGBMS may also have to conduct security searches at the venues to ensure the safety of customers and other persons at the relevant event.

Neither PCGBMS or their representatives are responsible for any loss, damage, or injury to persons or of property caused or sustained by you as result of attendance at any track day, save for liability for death or personal injury arising from PCGBMS's negligence or for fraudulent misrepresentation.

### **Driver Requirements**

All drivers must hold one of the following licences and comply with the relevant regulations in order to take part in a track day.

DVLA road licence - must be a fully unrestricted (not provisional) valid driving licence issued by the

DVLA (or the equivalent foreign licensing authority in the driver's country of residence and be 17 years or above) with the appropriate category clearly indicated.

### **Driving Standards**

All drivers must adhere to safety and driving standards set out at the driver briefing, anyone who does not follow these and is spoken to three times will be asked to leave with no refund for any part of the day being given.

### **Equipment Requirements**

All drivers and passengers must wear a suitable, correctly fitting crash helmet (not off-road style motorcycle helmets) and as per the circuit requirements have their legs always covered whilst on circuit if required. Notice of this will be given in the final instruction email received from PCGBMS. In the case of open top/soft top vehicles, drivers must wear full face helmets and have arms always covered.

### **Vehicle Requirements**

The vehicle you intend to use must conform to MOT minimum standards for road use (in the case of road cars). It must be in good condition both mechanically and bodily and suitable for its intended use on the track. All cars must have working seat belts/harness regardless of age and fit their towing eye in the front. It is your duty to ensure that the vehicle remains in this condition for the duration of the activity, in the interests of your safety and the safety of others at the circuit.

### **Non-Porsches**

Non-Porsches are not permitted.

### **Noise Restrictions**

The vehicle you intend to use must conform to our noise regulations.

If PCGBMS or the venue is of the opinion that any vehicle does not comply with the applicable noise restrictions, the relevant vehicle will be prevented from participating in the remainder of the event unless and until the noise emissions are addressed to bring them within the applicable limit. No refund will be given for any car not complying with the noise limit.

### **Passengers**

All passengers must be 16 years of age or over. PCGBMS reserve the right to limit the number of passengers per car at any circuit.
