1. I have/will before taking part, inspect(ed) the circuit/course and take note of the physical and other features present.
2. I will take part ONLY if I am satisfied as to the circuit/course, its layout, features and my safety.
3. **By** taking part, I accept the risks involved including the risk of injury or death to myself, others and damage to my and others' property.
4. I declare that I am competent to take part and (if I am driving) that I am in possession of a full current valid driving license for the type of vehicle I will be using.
5. I declare that my vehicle (driver only) using the circuit/course is in a safe and roadworthy condition, complies with all regulations and is fit to use for the activity for which I have attended today, I also declare that no representative of the PCGB or Harewood/BARC has examined or approved the vehicle for this purpose.
6. I am aware and accept that other participants will be on the circuit/course at the same time and will observe and obey all instructions given to me by BARC/Harewood staff and staff of the PCGB.
7. I declare that I am physically and mentally fit to take part in the activity for which I have attended today, and that I am not under the influence of any drugs or alcohol and that I will not consume any significant amount of alcohol nor any drugs whatsoever before using the circuit/course or whilst on the premises or bring any intoxicating liquor or foodstuffs onto the premises. I also declare that I am not currently undergoing any medical treatment or taking medication of any type or suffering from any disability that might impair or limit the control of the vehicle in which I am travelling or my ability to comply with the terms of this statement.
8. I have attended a drivers briefing (drivers only)
9. I am aware and accept that track activity is potentially an extremely dangerous activity and that I have a responsibility to act in a diligent and appropriate manner and in accordance

with best practice and applicable laws to reflect this potential risk and not place any pressures upon my allocated driver to perform in any manner different to his own professional competences.

10. I confirm that I will always be wholly responsible for any person accompanying me on to the premises (and not driving) and am aware & accept that nothing contained within this statement seeks to exclude or limit either the PCGB's or Harewood's liability for death or personal injury caused by its negligence, fraud or any other type of liability which cannot by law be excluded or limited.
11. I agree that the PCGB, Harewood, and their servants or agents will not be liable for any loss, injury or damage to any person (including myself) or property however caused (including by Harewood Hillclimb Ltd, the PCGB, or their servants or agents):
 - a. In any circumstances where there is no breach of a legal duty of care owned by the PCGB, or their servants or agents.
 - b. In any circumstances where such loss or damage is not a reasonably foreseeable result of any such breach (save for death or personal injury as a result of a breach of a legal duty of care owed by the PCGB, or their servants or agents); or
 - c. To the extent that any increase in any loss or damage results from breach by me of any of the terms of this statement.
12. In consideration of being accepted to take part in this track session, I agree to indemnify and keep indemnified, the PCGB, Harewood and their officials, servants, representatives and agents and other persons connection with the Event from and against all actions, claims, costs (including legal costs), expenses, damages and demands made by any person taking part in the Event or any other third party which results from my acts, omissions, negligence or any breach of this statement or any applicable law.
13. If driving, I agree not to drive in a dangerous, reckless, unsafe or inappropriate manner or to pass any pace vehicle, which may be used.
14. I understand that during the track session the use of crash helmets is required but the session is NOT timed, this is for participant safety only.
15. I acknowledge and accept that Harewood Hillclimb and the PCGB, or their servants or agents shall not be liable for any delay or non-performance or for the consequences of any delay or non-performance which is due to any cause or circumstances beyond its reasonable control.
16. I agree that if any provision of this statement is or becomes illegal, invalid or unenforceable under the law, that shall not affect or impair the legality, validity or enforceability of any other provision of this statement and acknowledge & accept that this statement is governed by and construed in accordance with English law and subject to the exclusive jurisdiction of the English courts.
