Donington Park Meeting Report

Drivers Briefing

- Carried out in person to all Drivers by Mandy Sear and David Scott MSVR

Qualifying 20/09/2025

- Track Dry, Weather cloudy.
- The session commenced at 09:41 and concluded at 10:01
- During the session,
- *Cars 33 & 88 require working transponders - NCR Ch.12 App.6 Art.2.2 refers.
- *Car 53 - transponder working intermittently, please check position.
- No. 2, 4, 5, 32, 44, 52, 56, 66, 144 - 1 Lap time disallowed, exceeding track limits.
- No. 33 - 2 Lap times disallowed, exceeding track limits.
- No. 14, 53 - 3 Lap times disallowed, exceeding track limits.
- No. 42 - 4 Lap times disallowed, exceeding track limits.

Race 2 (your race 1)– Round 6 – 20/09/2025

- Track Dry, Weather Overcast
- The session commenced at 12:50 and ran for 14 laps. The chequered flag was shown to the winner at 13:14.
- **DNF-** Cars 4,5,55
- **NC -** 78

Issues-

- *Car 53 - 5 second penalty for exceeding track limits.
- *Cars 33 & 88 require working transponders - please fix for the second race or you will not be timed - NCR Ch.12 App.6 Art.2.2 refers.
- *Cars 53 & 66 - transponder working intermittently, please check connection / reposition before the second race.

Car 52 Overtook Car 44 Under Double Yellow Flags at Coppice. The flags were displayed at the exit of McLeans (T7) due to a Car in the gravel at T8(Coppice) and a Live Snatch under way. The fact was broadcast several times on the Clerk to driver radio system. The drivers of Car 44 and 52 were interviewed.

Video evidence from Car 44 in the main. The video from Car 52 was unsatisfactory with very little forward vision available as the camera was misaligned but it was viewed.

Disqualified from the results of the race.

Number of Licence Penalty Points: 4

Stewards Decision - The appeal is not upheld.

The reason being the video footage from car No44 clearly shows the yellow board and waved yellow as the overtook took place. All before the green light board.

- • The session commenced at 15:44 and ran for 12 laps. The chequered flag was shown to the winner at 16.10.

Issues- Car 33 not timed, still no working transponder - NCR Ch.12 App.6 Art.2.2 refers.
