Brands Hatch GP Meeting Report Drivers Briefing

- Carried out in person to all Drivers by Mandy Sear and Andy Stevens MSVR

Qualifying 24/05/2025

- Track Damp, Weather Overcast.
- The session commenced at 10:31 and concluded at 10:51
- During the session, **Cars 71** Transponder not working correctly - regulation Q12.8.1 refers.

Race 4 (your race 1)

- Track Dry, Weather Bright.
- The session commenced at 14:14 and ran for 15 laps. The chequered flag was shown to the winner at 14:40.
- During the session
- Car 71 - Transponder still not working, please check fitting/location/charge.
- Car 23 - 5 second penalty applied for exceeding track limits.
- Car 96 - 12 second applied for causing a collision ref Reg Ch12 App7 Art1.8
- Car 8 - DQ for post-race scrutineering ref Reg Ch2 App8 Eligibility

DNF- Cars 64 & 99 **DQ-** Cars 8

Issues- Car 96:

Ch.12 App.7 Art.1.8 Causing a collision, repetition of serious mistakes or the appearance of a lack of control over the car (such as leaving the track) will be reported to the Clerk of Course and may entail the imposition of penalties up to and including the disqualification of any driver concerned.

During race, contact reported at turn 7 between cars 96 and 86. Reviewed on board from both cars and spoke to driver of 96 (Charlie Dye). Could see as 96 overtook 86 he moved to drivers left before he was clear of car 86. Contact was made and 86 lost time. Penalty such to place car 96 behind 86 in results. Additional Comments: 12 seconds added to race time - Points on licence Penalty point – 3

Car 8 Ch.2 App.8 Eligibility - Post Race Scrutineering

Bertie's mother was unavailable, so guardian passed to driver coach Richard Fores.

Reported as being 5kg underweight. Weighed 1345kg, should be 1350kg. CR 45.1 App 1 refers.

Driver and guardian unable to provide exceptional circumstances, so disqualification appropriate. Disqualified from the results of the race.

Race 9 (your race 2)

- • Track Dry, Weather Cloudy.
- • The session commenced at 18:00 and ran for 10 laps. The chequered flag was shown to the winner at 18:20.
- Car 71 - Transponder still didn't work - check location for future rounds.
- Car 27 - NC as not running at time of red flag.
- **DNF**- Cars 99
- **NC** – Car 27

Issues- None.
