Drivers Briefing

Carried out in person to all Drivers by Mandy Sear and Andy Stevens MSVR

Qualifying 02/08/2025

- Track Dry, Weather cloudy.
- The session commenced at 09:27 and concluded at 09:47
- ` *Cars 4, 27 & 33 please fit a working transponder before your next session NCR Ch.12 App.6 Art.2.2
- *Cars 53, 66 & 71 intermittent transponder signals please rectify before your next session-NCR Ch.12 App.6 Art.2.2
- No. 3, 6, 9, 15, 22, 26, 43, 51, 52, 64, 66, 88 1 Lap time disallowed, exceeding track limits.
- No. 4, 8, 33, 96 2 Lap times disallowed; exceeding track limits.
- No. 14 3 Lap times disallowed, exceeding track limits.

Race 2 (your race 1)- Round 5 - 02/08/2025

- Track Dry, Weather Cloudy
- The session commenced at 13:20 and ran for 9 laps. The chequered flag was shown to the winner at 13:45.
- **DNF-** Cars 64,22,85,32,4,96
- NS Cars 23, 5.
- *Car 33 transponder still not working please rectify before your next session NCR Ch.12 App.6 Art.2.2
- *Cars 53 & 71 intermittent transponder signals please rectify before your next session-NCR Ch.12 App.6 Art.2.2

Issues-

- First corner incident between cars 81 and 96. Car 81 on inside making a move. Contact caused 96 to spin and car 81 continued. Unable to apportion blame to either driver. No further action
- Car 77 reported that car 56 left the track and gained an advantage. On reviewing the footage from car 77 it showed that car 56 did not entirely leave the circuit so was a legitimate overtake. No further action
- Asked the driver of car 18 to bring up footage from the race but when opening the card, it said there was no media. After interviewing the driver, it was stated that there was a formatting error which meant the card did not record and they can't tell until the car is moving. They will look to resolve the issue. No further action

Race 7 (your race 2)- Round 5 - 02/08/2025

- Track Dry, Weather cloudy.
- The session commenced at 17:26 and ran for 9 laps. The chequered flag was shown to the winner at 17:54.
- DNF- Cars 20,55,85,81,6.
- **NS**-22,5,64.

Issues-

- *Cars 3, 86 & 99 5 seconds added to race time for overtaking under safety car
- *Car 8 1 position penalty for Ch.2 App.1 Art.1.14 overtaking under safety car conditions
