Driver's Declaration

I confirm that I meet the following Driver Eligibility Criteria:-

- I am aged 25 or over and am a permanent UK resident.
- I hold a full UK driving licence and that I have gained no more than 9 penalty points in the last five years.
- I have no endorsements, prosecutions or police enquiries pending for any conviction (other than speeding).
- I have not been subject to a driving disqualification in the last five years.
- I have not made more than two accident/loss claims in the last five years.
- In accepting the loan of ALB 223A, I acknowledge that it is the Club's property and it is provided to me on loan for the purpose stated above, subject to the following conditions:
 - a. I am not responsible for arranging and maintaining comprehensive insurance cover for the vehicle whilst it is in my possession.
 - b. I will return the vehicle and the ignition keys to the Club's authorised representative (whose name has been provided to me) at a designated place when I have completed the aforesaid drive (or as soon as possible if I am unable to complete the drive).
 - c. I will drive the vehicle within the applicable speed limits and obey the rules of the Highway Code. I will use the vehicle in a lawful and proper manner, with reasonable care, will not drive the vehicle whilst under the influence of alcohol or drugs and will not drive the vehicle in the event of mechanical, electrical or structural failure or damage (if further damage might thereby be caused). I will inform the authorised representative of the Club if the vehicle suffers any damage or loss or develops any fault whilst the vehicle is on loan to me, as soon as possible. I will not drive the vehicle in an inappropriate manner such as

incorrect gear changes, over revving the engine or any other such action that may cause damage to the vehicle.

- d. The vehicle will only be driven by me and only for the above purpose.
- e. I will be responsible for all penalties and charges of any nature which arise as a result of breach of statute, regulations or any civil law in connection with or in relation to the use and operation of the vehicle whilst it is in my custody and control including speeding tickets, parking tickets and any fines.
- f. If the vehicle has to be left unattended, I will remove the ignition keys, lock the doors and close the windows and make all reasonable efforts to ensure vehicle security and to prevent loss of or damage to it.
- g. I hereby undertake to indemnify the Club against all liabilities for claims, demands, actions, suits, losses, costs, charges, expenses, damages, death, personal injury (whether fatal or otherwise) caused during the loan to me of ALB 223A (other than any which are insured).
- h. I have read and understood the notes below (which form part of this Agreement) entitled "In the Event of an Accident" and will adhere to them.

This agreement contains the entire understanding between the parties and no alterations or additions to it are valid unless made in writing and are signed by both the Club Member and an authorised representative on behalf of the Club.

(You are compelled to provide such information by the Road Traffic Act 1988 – A copy of the Insurance Certificate is included in the information pack held in the car).
- 4 Obtain the names and addresses of any witnesses.
- 5 Record the position in the road of your vehicle and any other vehicle involved
- 6 As soon as you are able, notify the Insurers (details supplied in the information pack) and Porsche Club Great Britain on 01608 652911 (8.30am to 5pm).
- 7 Where appropriate, notify the Police.
